

# Contract of Employment

This contract of Employment (henceforth referred to as the "Contract") is duly agreed upon and sealed between the esteemed Gravediggers' Guild (hereinafter referred to as the "Gridger").

### 1. Position and Duties:

- 1.1 The Gravedigger shall be granted full admission to the esteemed ranks of the Guild.
- ${\bf 1.2}$  The Gravedigger's principal duties include, but are not confined to:
  - A. The timely and reverent interment of departed souls.
  - B. The meticulous observance of appropriate burial rituals, as decreed by the sacred traditions and customs of the Guild.
  - **c.** The competent and unflinching reinterment of any unquiet dead encountered during the course of service.
  - D. The vigilant upkeep of the dignified appearance befitting consecrated burial grounds.

## 2. TERM OF SERVICE:

2.1 This Contract shall be solemnly enacted on this day and remain binding until such a time as it is lawfully dissolved, in accordance with the terms herein.

### 3. Compensation and Perquisites:

- 3.1 The Gravedigger shall be justly compensated with the following emoluments and rewards:
  - A. A monthly stipend of 13 obols, to be dutifully disbursed on the last day of each month.
  - B. The bestowal of essential tools, including a gravedigger's spade and a badge of office, requisite for the honourable discharge of the duties expounded upon in Section 1.

### 4.. Hours of Labour:

- 4-I The Gravedigger shall adhere to the hours of labour as ordered by the Guildmaster or any duly authorised representative thereof.
- 4.2 The Gravedigger may be called upon to fulfil their obligations on holy days and during nocturnal hours, as necessitated by the exigencies of the Guild.

### 5. TERMINATION:

- 5.2 The Guild reserves the right to immediately dissolve this Contract, without prior notice, should the Gravedigger breach the hallowed rules and regulations of the Guild or otherwise commit an act of misconduct.
- 5.3 In the event of dissolution, the Gravedigger shall forthwith return any Guild property or equipment within their possession, then present themselves to the Justiciars for judgment and thus honouring the Guild's principles of loyalty and fealty.

### 6. Governing Law:

6.1 This Contract shall be governed by and construed in accordance with the sacred laws of the Justiciars, recognised and endorsed by Divine Authority.


## 7. Entire Agreement:

7.1 This Contract stands as the complete embodiment of the accord struck between the Guild and the Gravedigger, supplanting any prior negotiations, understandings or agreements, whether written or spoken, relating to the Gravedigger's sacred vow.

The esteemed Guild does not shield the gravedigger from any unjust distinction, vexation or undue hardship on account of their lineage, rank or ongoing and future heresies. The Guild does not bear responsibility for the safety and well-being of the Gravedigger. The Gravedigger does not possess an inherent prerogative to voice their concerns, grievances or disputes in matters concerning their employment. The Gravedigger should provide their own occasions for refinement and progression, as well as access to pertinent tutelage, patronage and augmentation of skill, therefore fostering their upward mobility within the Guild. The Gravedigger can under no circumstances dissolve this contract. Any such claims of dissolution shall be brought before the Justiciars with due prejudice.
